## Information Sought:

It is understood that Powergrid AC substations needs auxiliary power. As a general practice, the power is drawn usually by 2 feeders, one feeder from state DISCOM and other from the power drawn through tertiary winding of ICTs. I seek below information under RTI act.

- (1) Whether the power drawn through tertiary of ICTs is free power or PGCIL is paying to respective state utilities.
- (2) Whether is there any allocation of auxiliary power to PGCIL AC substations, from SGCs (To be drawn through tertiary winding of ICTs).
- (3) If power drawn from tertiary winding of ICTs is not free, and PGCIL is paying to respective state DISCOM (Where the relevant PGCIL sub station is located), my question is, whether PGCIL is paying only energy charges OR capacity charges also.

## Reply:

- (1) Payment against consumption of electricity for auxiliary power consumption is being done to respective DISCOMs
