Q 1. Number of senior GMs who got promoted to Chief GMs in the last 03 years.

Reply: Nil

Q 2. Number of Chief GMs who got promoted to Executive Directors in the last 03 years.

Reply: Total 36 nos. of E8 level executives got promoted to ED in last 03 years.

Q 3. Number of Senior GMs who were promoted to Executive Director post in the last 03 years.

Reply: Nil

Q 4. Number of Chief GMs promoted to Executive Director post in the last 03 years.

Q 5. Total No. of Executive Directors in PGCIL as on date.

Reply: Total 36 nos. EDs in POWERGRID as on date (Including on deputation)

Q 6. How many Executive Directors were holding the designation of Senior GM before they got promoted as Executive Director. Report of last 03 years may be provided.

Reply: Sr. GM (E8) position was introduced in October 2018. None of the executives designated as Sr. GM in October 2018 and thereafter have attained eligibility for promotion to ED (E9) level.

Q 7. How many Executive Directors were holding the post of Chief GM before they got promoted as Executive Director. Report of last 03 years may be provided.

Reply: As replied against Query no. 2.

Q 8. What is the seniority level of the following in PGCIL (not in terms of E08/E09 but years of service and rank) GM, Senior GM, Chief GM, Executive Director? what is the order of their seniority. can a Chief GM become Senior GM on promotion? Kindly elaborate on how a person at the level of GM will become executive Director i.e GM to ED stage wise.

Reply: GM, Sr. GM and Chief GM fall under E8 level and promotion is not operated within same level. Executives falling under this level are amongst the senior level of the management. In order to prepare them for leadership role for the organization they are assigned different responsibilities and are designated as General Manager, Senior General Manager and Chief General Manager etc.

Executive Director falls under E9 level which is one level higher than E8 level.

Q 9. In the last 03 years how, many GMs were promoted to Executive Director.

Reply: Total 36 Nos Executives in E8 grade were promoted as ED.
