

1)	What is the status of your PSU?	Maharatna PSU
2)	What is the Market Capitalization of your company?	The current Market Capitalisation of POWERGRID can be seen on the NSE/BSE Index.
3)	How many employees work in your company?	POWERGRID has 9029 employees on rolls of company as on 31-08-2021 (including contractual employees)
4)	How many employees have been posted at single / particular location (i.e. site office/project office/ Head office/ corporate office) since joining of employees in your company?	Data in the requested form is not readily available. Further, creation of such voluminous data would disproportionately divert the resources of the organisation and is therefore is avoided under Section-7 (9) of RTI Act. Also, if information regarding any particular employee is required, the same can be provided subject to consent of third party.
5)	How many employees have been posted at single / particular location (i.e. site office/project office/ Head office/ corporate office) since last 25 years in your company?	
6)	How many employees have been posted at single / particular location (i.e. site office/project office/ Head office/ corporate office) since last 10 years in your company?	
7)	Where can I find all the tenders floated by your company?	The tenders related information can be accessed from the hyperlink given below: https://apps.powergrid.in/pgciltenders/u/default.aspx
8)	How can the change in govt. regulations/ policies on tariff mechanism affect your revenue/ capitalization?	The information sought does not fall under Section 2 (f) of RTI Act, 2005.
9)	Percentage of awards placed by your company which have been completed within their work schedule?	The information sought is voluminous in nature. Further, establishments of POWERGRID are spread all over the length & breadth of the country and various operations & functioning of the Organisation are being carried out in a decentralised manner and its records are maintained at the respective locations. For compiling such voluminous information, a considerable amount of time and resources would have to be deployed by POWERGRID and it could disproportionately divert the resources of the Public Authority. Therefore, in line with Section 7 (9) of RTI Act, 2005, aforesaid information is not being provided.
