ORDER

The Appellant **Ms. Akanksha Singh, Project Assistant, Paramount Wires & Cables Ltd. M-5A, Bahubali, Ist. Floor, Plot No.59/17, New Rohtak Road, Karol Bagh, Delhi-110005** vide her RTI Application Dt.02.09.2021 (received on 06.09.2021) had requested for furnishing certain information under the Provisions of Right to Information Act-2005. CPIO, NR-I had denied to provide information as per the provisions of RTI Act-2005 vide his letter No.POWERGRID/NR-I/RTI/2049/2165 Dt.09.09.2021.

Now, first RTI Appeal dt.21.09.2021 u/s 19(1) of the RTI Act, 2005 has been filed by Appellant **Ms. Akanksha Singh** in the office of First Appellate Authority (Received on 24.09.2021). In her appeal, the appellant has mentioned that CPIO has denied to provide information under section 8(1) (j) and 11(1) of RTI Act,2005. The appellant has also mentioned in her appeal that the said provisions does not debar the CPIO in providing the desired information.

Ongoing through the contents of RTI Application dt.02.09.2021 on which the information sought, Appeal Dt.21.09.2021 and subsequently the submission of CPIO, POWERGRID, NR-I has been heard. Vide letter dt.09.09.2021 CPIO, NR-I has mentioned that the information desired has denied because it is exempted under the said provisions of RTI Act, 2005. Further, CPIO has also submitted that the request of M/s Inventive Growth vide letter dt.17.08.2021 was considered and, therefore, the denial under section 11(1) has been imposed.

Keeping in view the above discussion, it is emerged that the denial after imposing exempted provisions/clauses of RTI Act, 2005 by CPIO, NR-I is in order. Hence, the appeal is disposed-off.
