Re: Appeal against the order of your CPIO.

Dear Sir,

We vide our application dated: 02-09-2021 sought information under Section 6 of RTI Act, 2005 from CPIO in regard to payment remitted to Inventive Growth International Engineering Services PVT.LTD. We state that the Latter Company was issued Work Order No. N 1/C&M/17-18/ULDC/LOA/72 DATED: 31-08-2017. A copy of said application is being enclosed for your ready reference.

We may inform that your CPIO vide his letter Ref: POWERGRID/NR-1/RTI/2049/2165 DATED: 09-09-2021 has conveyed that the information sought by us cannot be provided as the said company vide their letter dated 17-08-2021 has directed them not to disclose and pass any information related to them as the information sought is exempted under section 8(1) (j) and 11(1) of RTI Act, 2005.

We give below the provisions of the Act which has been considers by you CPIO for denying the information sought under the Act.

8. (1) "Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen, — (a) information, disclosure of which would prejudicially affect the sovereignty and integrity of India, the security, strategic, scientific or economic interests of the State, relation with foreign State or lead to incitement of an offence; (b) information which has been expressly forbidden to be published by any court of law or tribunal or the disclosure of which may constitute contempt of court; Exemption from disclosure of information.

(j) information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information: Provided that the information which cannot be denied to the Parliament or a State Legislature shall not be denied to any person.

11. (1) Where a Central Public Information Officer or a State Public Information Officer, as the case may be, intends to disclose any information or record, or part thereof on a request made under this Act, which relates to or has been supplied by a third party and has been treated as confidential by that third party, the Central Public Information Officer or State Public Information Officer, as the case may be, shall, within five days from the receipt of the request, give a written notice to such third party of the request and of the fact that the Central Public Information Officer or State Public


Information Officer, as the case may be, intends to disclose the information or record, or part thereof, and invite the third party to make a submission in writing or orally, regarding whether the information should be disclosed, and such submission of the third party shall be kept in view while taking a decision about disclosure of information: Provided that except in the case of trade or commercial secrets protected by law, disclosure may be allowed if the public interest in disclosure outweighs in importance any possible harm or injury to the interests of such third party."

If you go through stated provisions of the Act, the said provision doesn't debar the CPIO in providing the desired information as this can easily be provided to Hon'ble of Parliament of India and state Legislature. Further section 11(1) shall apply if the information is provided by a third party to (Inventive Growth International Engineering Services PVT.LTD.) which is not the case in present matter. Thus, your CPIO cannot deny the information sought by us by seeking a blanket protection of the provisions of Act, 2005.

It is therefore requested that CPIO may be directed to provide information sought by us vide our application dated: 02-09-2021
