I have received the incomplete and irrelevant answers for the above mentioned RTI and the details of the incomplete answers are mentioning here for your kind information and necessary action. 1. For Q. No.1 to 4 Reply:- The information sought is voluminous in nature. Further, establishments of POWERGRID are spread all over the length & breadth of the country and various operations & functioning of the Organisation are being carried out in a decentralised manner and its records are maintained at the respective locations. For compiling such voluminous information, a considerable amount of time and resources would have to be deployed by POWERGRID and it could disproportionately divert the resources of the Public Authority. Therefore, in the line with Section 7(9) of RTI Act, 2005, aforesaid information is not being provided. If any specific information is sought the same, may be provided. 2. For Q. No.5 & 6 Reply:- No such information is available 3. For Q. No. 7 (a to e) & 8 Reply:- The information sought is voluminous in nature. Further, establishments of POWERGRID are spread all over the length & breadth of the country and various operations & functioning of the Organisation are being carried out in a decentralised manner and its records are maintained at the respective locations. For compiling such voluminous information, a considerable amount of time and resources would have to be deployed by POWERGRID and it could</p>
