No.5 Reply: There is no new additional Grade as asked in the above question. The post of Sr.DGM is in existing E7 Grade and the posts of GM, Sr.GM and CGM are in E8 Grade. Information requested: If the DGM and Sr DGM are in E7 Grade, GM, Sr.GM and CGM are in E8 Grade, please provide the copy of approval from Ministry of Power/DPE or any other Govt. body to create the different designations in the above mentioned E7&amp; E8 Grade. Due to the above-mentioned issues from 1&amp;2, I am not satisfied with replay of the Powergrid CPIO CC and it is requesting you to provide the full information against my RTI.
