**Grounds of Appeal**


**Order:**

In my considered opinion, the requested information for sl.no.5 has already been provided vide the reply dated 14/10/2021. Further, as far as information related to sl.no.4, is concerned, the CPIO is hereby directed to provide the information

related to Senior DGM, Senior GM, and CGM transferred to other projects/regions after their re designation within fourteen days of this order.

With the abovementioned observations, the appeal is disposed of.
