### **ORDER**

#### **Grounds of Appeal**

The Appellate Authority has received an online appeal bearing number PGCIL/A /E/21/00061 dated 20/12/2021 from Mr. Mahesh Kumar Mittal, (appellant). Earlier, the appellant herein had filed an online RTI application bearing number PGCIL/R/E/21/00461 dated 28/11/2021, with the CPIO Corporate Centre. The instant appeal has been preferred on the ground that the CPIO has refused access to Information.

#### Order:

I have seen the above mentioned RTI application filed by the appellant. I have also perused the reply dated 16/12/2021 sent by the CPIO wherein it was stated that the payment/settlement of Gratuity of an employee is personal information and disclosure of the same does not have any public interest.

In my considered opinion, the appellant has failed to establish any public interest that would be served by disclosing the information. Any disclosure will surely cause unwarranted invasion of the privacy of the individual and as such no public purpose would be served. Section 8 (1) (j) of the Act, prohibits disclosure of personal information which has no relationship with any public activity. This appeal squarely falls within the ambit laid down by the section.

In view of the foregoing submissions the information sought by the appellant cannot be provided.

Accordingly, the appeal is disposed of.
