- 2. The scheme will be implemented as a Central Sector Scheme through Power Grid Corporation of India Ltd (PGCIL). The entire cost of the project will be borne by Government of India through Plan scheme of Ministry of Power. The States will reimburse State levied taxes and duties as applicable on the project, as already committed by them.
