The Details which were provided by PGCIL to DoT in response to the said request.</li> </ol> <p>I would request that in case your kind authority considers any part of the desired information as non-disclosable, then please exercise due discretion, effect segregation and provide me at least that part which may be disclosed to a RTI applicant.</p> <p>Further if the information is bulky then I may be provided only first and the last two pages of both the documents.</p> <p>Scanned copies may be provided on the given email id please.</p>	<ol style="list-style-type: none"> <li>1. During regular scrutiny on 01.05.2018 of POWERGRID Internet lease Line Customers by NE LSA Imphal Team, it was found that one customer is misusing the ILL connection and reselling it without having proper License.</li> <li>2. As soon as the issue came in notice to the POWERGRID, the link of customer was terminated.</li> </ol> <p>Being a regulatory issue, further information may be sought from DoT, the Regulator.</p>
