

ORDER

Grounds of Appeal

The Appellate Authority has received an online appeal bearing number **PGCIL/A/E/21/00060** dated **08/12/2021** from Sh. Yogendra Rathod, (appellant). Earlier, the appellant herein had filed an online RTI application bearing number **PGCIL/R/E/21/00476** dated, **06/12/2021**. The instant appeal has been preferred on the ground that the CPIO has not provided the information.

Order:

It can be seen that the appellant herein had filed the RTI application on 06/12/2021 and the appeal was filed two days thereafter i.e. on 8/12/2021. On enquiry it was informed by the CPIO that the attachment appended with the RTI application could not be opened / downloaded, so the RTI application was returned to applicant, mentioning the same, on 08/12/2021 through RTI MIS Portal. The applicant instead of resending the attachment chose to prefer an appeal and attached the original RTI attachment with subject appeal.
