ORDER

Grounds of Appeal

The Appellate Authority has received an appeal ref. **PGCIL/A/E/22/00002 dated 06/01/2021** from Mr. Shri N Prathap (appellant). Earlier, the appellant herein had filed an RTI application ref. PGCIL/R/E/21/00496 dated 21/12/2021, with the CPIO Corporate Centre, seeking information related to details regarding Ex-FTB employees Pay protection rules and benefits. The instant appeal has been preferred as the appellant is seeking clarification for the information already provided.

Order:

I have seen the aforesaid RTI application and have also perused the reply dated 05/01/2022 sent by the CPIO and other relevant documents. The appellant in the subject appeal have acknowledged the said reply, however expressed his/her inability to understand the same and requested further clarification. In my opinion the appellant has not raised any issue with respect to the adequacy of the information provided however he is seeking clarification in respect of the information provided. The appellant is seeking information regarding basic pay of former FTB employees who were relieved on or before 2019 (whose monthly salary was consolidated pay) but who have rejoined as fresh candidates.

In my considered opinion, the information sought has already been provided however if any further information is available the same may also be provided to the appellant.

In terms of the order, the CPIO is hereby directed to provide any further information, if any, to the appellant within fourteen days of this order.

The appeal is accordingly disposed of.
