**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an offline RTI Appeal received on 25-02-2022 from Shri Lalit Kumar, (appellant). Earlier, the appellant herein had filed an offline RTI application received on 04-01-2022, reply of which was given by CPIO vide their letter dated 02-02-2022. The instant appeal has been preferred on the ground that the CPIO has provided incomplete information in respect of Query No. 1 to 4, whereas information in respect of Query No. 5 has been denied and the authentic documents referred in Query No. 6 to 8 have not been provided.

**Order:**

I have seen the above referred RTI application. I have also perused the reply sent by the CPIO and other relevant documents. It can be seen that in respect of Query No. 1 to 4, CPIO had furnished the desired information for Corporate Centre only, however the applicant had requested the information for POWERGRID. Further in respect of Query No. 5 to 8, in my considered opinion CPIO have already provided the information as was available and covered under the definition of 'information' as defined under RTI Act 2005.

CPIO is hereby directed to provide the information in respect of Query No. 1 to 4 to the appellant within thirty days of this order.

With the abovementioned observations, the appeal is disposed of.
