1.	What is the verification procedure being followed in case of a foreign address is mentioned on Attestation Form?	In such cases, we approach to concerned authority/ Embassy/ concerned office of MEA, GoI for verification of relevant document(s) submitted by individual employee.
2.	Is verification of Present Address is also mandatory?	Verification of places of residence where concerned employee have resided for more than one year at a time during the preceding five years. In addition to above, Home (Permanent) Address is also verified.
3.	What is the verification procedure being followed if address provided in Attestation Form is a temporary/PG address without any address proof?	As per reply of Q.No. 02 above.
4.	What is the course of action followed by your organization if report of Character & Antecedents is not received within probation period?	Interim order to release initial increment is issued. Final confirmation order is issued subject to receiving of all satisfactorily verification reports from concerned authorities.
5.	What is the modus operandi to expedite the verification of Character & Antecedents?	The context of above question is a query and not any information sought under RTI Act. Accordingly, answer to this query does not qualify as "information" as per clause 2 (f) of the RTI Act, 2005. The company is not bound to reply to this query under RTI Act
6.	Is antecedents verification of all entries of Attestation Form along with permanent and present address is mandatory before closure of probation period?	As per reply of Q.No. 02 above.
