2.	In case of resignation of an PGCIL employee does PGCIL policy provide transfer for Superannuation Fund/ Trust accumulations (balance fund) to the NPS (National Pension Scheme)Fund/ Trust in case the the resigned employee joins a Central/State Government organisation? If yes, then please provide terms of such transfer.

Relevant Clause of Pension Scheme

7.3 In case of Resignation:

(i) Resigns from service and joins another CPSE where similar scheme exists

If the employee resigns from the company and joins another CPSE where similar scheme exists, the entire amount of corporation's contribution and member's contribution along with interest accrued thereon shall be transferred to such CPSE provided the CPSE agrees to accept the fund transfer and the request for transfer through proper channel.

(ii) Resigns from services & joins another CPSE where similar scheme does not exist or joins any organisation which is not a CPSE or does not join any other organisation subsequent to separation

In case the CPSE does not have a similar scheme, or does not accept such transfer; or in case the employee joins any other organisation which is not a CPSE or the employee does not join any other organisation subsequent to separation, then such resigning employee will have two options:

- (i) Annuity will be purchased on total accumulated contribution (both employer + employee contribution)
- (ii) Transfer of total accumulated contribution to the individual NPS account.
