ORDER

The Appellant Shri Rajendra Prasad, 203, Haripriya Apartments Tilak Road Meerut-250001 vide his Online RTI Application Registration No.PGCIL/R/E/22/00141 Dt.15.04.2022 with regard to 132kV Sakauti-Hapur Transmission Line (DFCCIL) had requested for furnishing information under the provisions of Right to Information Act, 2005. CPIO, CC through RTIMIS Portal has rejected and returned back the RTI application by mentioning that information sought does not pertain to POWERGRID.

Now, first Online RTI Appeal vide Registration No.PGCIL/A/E/22/00016 Dt.20.04.2022 has been filed by the appellant through RTIMIS Portal. Vide his appeal the appellant has attached an agreement between Dedicated Freight Corridor Corporation of India Limited and POWERGRID, on the basis of the same he tried to prove that the contents on which the information sought by him is pertains to POWERGRID.

Therefore, ongoing through the contents of Online RTI Application and Appeal the concerned office/site directed to provide input/information desired by the appellant in respect of Tower Number starting from 1/0 Loop-in to Tower No.16/0 Loop-in and Tower Number starting from 19/0 Loop-out to Tower Number 39/0 Loop-out of 132 kV Sakauti-Hapur Transmission Line (DFCCIL). In this regard, para-wise information is as below:
