ORDER

The Appellant **Shri Rajendra Prasad, 203, Haripriya Apartments Tilak Road Meerut-250001** vide his Online RTI Application Registration No.PGCIL/R/E/22/00142 Dt.15.04.2022 with regard to 132kV Sakauti-Hapur Transmission Line (DFCCIL) had requested for furnishing information under the provisions of Right to Information Act, 2005. CPIO, CC through RTIMIS Portal has rejected and returned back the RTI application by mentioning that information sought does not pertain to POWERGRID.

Now, first Online RTI Appeal Registration No.PGCIL/A/E/22/00017 Dt.20.04.2022 has been filed by the appellant through RTIMIS Portal. Vide his appeal the appellant has attached an agreement between Dedicated Freight Corridor Corporation of India Limited and POWERGRID, on the basis of the same he tried to prove that the contents on which the information sought by him is pertains to POWERGRID.

Therefore, ongoing through the contents of Online RTI Application and Appeal the concerned office/site is directed to provide input/information desired by the appellant. In this regard, para-wise information is as below:
