Reply (1): In exercise of the powers conferred under sec. 164 of the Electricity Act of 2003, the Central Government being the "Appropriate Government" has conferred the powers of "Telegraph Authority" upon the Appellant vide notification no. 1148 dated: 24.12.2003 published in Gazette of India. Accordingly, POWERGRID has been conferred with powers of a Telegraph authority under part III of the Indian Telegraph Act of 1885 and thus authorized to lay the poles, wires, posts etc. Upon, across, along, over or under any immovable property as per Sec10 of the Indian Telegraph Act of 1885.

Further under section 10(d) of Indian telegraph act inter-alia while laying down the wires, poles, posts upon the land POWERGRID do little damage as possible and pay full compensation for the damage sustained and as per section 10(b) of the said act Telegraph authority i.e. POWERGRID shall have a right as user in the property under, above, along, across in or upon the transmission line.
