PI refer para-2 of the response of the CPIO attached here, which declines all requisite information under section 8(1)(j). Such blatant denial is against the very purpose of the RTI Act and there is nothing in the request which is covered in the RTI Act. But the learned CPIO has rejected everything, even the names and basic details of the persons whose details were requested. You are, therefore, requested through this First Appeal to--

1. Ask the concerned learned CPIO to provide all details requested in para-2. If any particular personal detail is considered as strictly personal information, you can ask the learned CPIO to hide that particular information but all other details about all the persons should be given as soon as possible.

2. Any other action you may want to take on this matter.
