

In details, that The Power Grid Corporation of India Ltd, Gurgaon a Government of India enterprises Company has recently constructed a High Power Transmission Line traversed and passed effected by covering major part of my land admeasuring to an extent of Acre 1.71 Cts (8276.5 Sq Yds) of such activity of project corridor in valuable land of R.S.No 471 in between the Tower No 45/1 & Tower No 45/2.

Undoubtedly, the project which you've taken for public use is the most important and beneficial for everyone, I too hurtfully support in the interest of our beloved India. As an Indian I am really proud and feel happy to give my land for the good cause, at the same time so sad to say that your company authorities neither served notice of intimation to me nor obtained my approval/consent by making compensation for RoW transmission line passed covering my land. That the land utilized/obtained by your company is valued in square yards at the S.R.O. Jangareddigudem useful for commercial purpose belongs to my two little daughters, kept to settle them well in future.

Therefore, the CMD, PGCOI, is requested earnestly look into the matter and order your company authorities to compensate as per market value for the loss of land utilized /obtained in the benefit of your company without my consent. Or else irreparable damages occur to me and my family. Pleased to consider in the interest of Justice.
