#### ORDER

In pursuance of the Govt. letter no. LR-78/84 Dated, Itanagar the 8<sup>th</sup> January'2021, a plot of land measuring 20,235.00 sq.mtrs of land described below is hereby allotted to Power Grid Corporation of India Ltd., Lower Subansiri District, Ziro for construction of 132/33kV Ziro Sub-station subject to payment of land value@Rs.10/- per Sqmtr only and other terms and conditions for allotment of govt. land.

The following conditions are attached to this allotment.

- i) The allottee shall be liable to pay the land value of such rates as may be fixed by the Govt. from time to time.
- ii) The allottee shall not sub-let or sub-allot any portion of land so allotted to any other organization or individuals without prior approval of the government.
- iii) The allottee shall not utilize the land for the purpose other than for which it was allotted.
- iv) The allottee may surrender the allotted land. On such surrender being made, the government shall refund land value paid by the allottee or pay the market value of the land whichever is less.
- v) On such resumption of land by the govt. under (iv) above, the govt. shall allow a period of six months to enable the allottee to remove his assets from the said or if mutually agreed pay compensation for the construction made by the allottee on the subject land on the basis of the present day cost minus depreciation of the building. The valuation for this purpose shall be obtained from the Public Works Department.


