As per compliance of Appellate Authority Order No. C/CP/AA/RTI Act, 2005 dated July 14, 2022. The requested information is given as below:

RTI Query:	<p>I had served PGCIL in two services from more than five years.i.e From 7.9.2016 upto 15.5.2018 and From 18.5.2018 upto 1.11.2021. Now I want withdraw my EPS amount from EPFO, For that I had submitted claim on EPFO Portal but my claim has been rejected citing that my date of joining is 23.4.2018 but contribution deposited from nov 2018 please clarify. I had tried to reach both PGCIL and EPFO but none had clarified. So kindly provide me my detailed contribution made by the establishment i.e PGCIL towards my eps on epfo so that it would be clarified. Also kindly provide my total EPS amount available at EPFO. The Service Certificates are attached for kind information.</p> <p>My UAN NO is 101377854753</p>												
Original RTI Reply:	<p>You have opened two Universal Account Numbers (UANs) for your two tenures of service in POWERGRID and EPFO provides that only one UAN is allowed, which is transferable to new job/organization. While working in POWERGRID for different tenures, your EPS-95 monthly contribution as prescribed has been remitted to EPFO in the respective UANs. Further, you may approach EPFO, Dwarka, New Delhi to rectify the issue by getting merged both the UANs.</p>												
Ground for Appeal:	<p>I had asked to provide my complete contribution paid by PGCIL on behalf of EPS-95 to EPFO for the services i.e From 7.9.2016 upto 15.5.2018 (Emp. No. 90088602) and from 18.5.2018 upto 1.11.2021(Emp. No. 90088636) and total amount of EPS-95 pending on EPFO as PGCIL had contributed to EPFO.</p> <p>But besides that you are asking that I had opened two UANs but with due respect sir UAN no. had been created by PGCIL HR department and any modification is only accessed by PGCIL HR department and hence if merging required it shall be done by PGCIL HR department. If it is only up to me at least kindly share my two UAN no as I had only one UAN no in my Knowlwdge i.e 101377854753. So kindly provide me my other Uan no as per your reply so that it will be merged.</p>
