A.P. ROW corridor in land R.S.No 471 covered land admeasuring A1.75 Cts between Towers 45/01 to 45/02 in plot no. 49 and Plot No 48.

1. Under which act or guidelines or rules the PGCIL is entitled to enter in my land for establishment of ROW corridor without serving "NOTICE" to the AFFECTED LAND OWNER.
2. Under which act or guidelines or rules the POCIL is entitled to transfer compensation into my bank account on without my permission without redress the grievances as mentioned in the above table and pending at District Collector W.O.Dt (24.07.2019) and pending complaint at MOP dated 05.03.2019.
3. Obtain a copy of Notice served to Affected Person signed by "Tallada Dilip Goud" and not others from POCIL and provide a copy of the same to me.
4. Obtain authorization letter given by "Affected Person" to POCIL authorities for accepting compensation to transfer into his bank account.
5. Obtain account details of PGCIL to return the compensation amount Rs.1,79,520/- illegally transferred into my bank account on 18.04.19 without my consent and pending complaints at non redressed. Pl refers letter dated 22.04.2019 and Secretary MOP dated 21.05.21 encl with this application.
6. Action taken by the Ministry against POCIL on the above irregularities by POCIL in establishment of ROW corridor in a private land.
7. Provide me a remedy to approach for Justice of above.

15. Violation of a person's property rights is an expansion of force against the person. The State should not use its coercive power to force a person to share his wealth with the law state. True charity cannot be compelled.

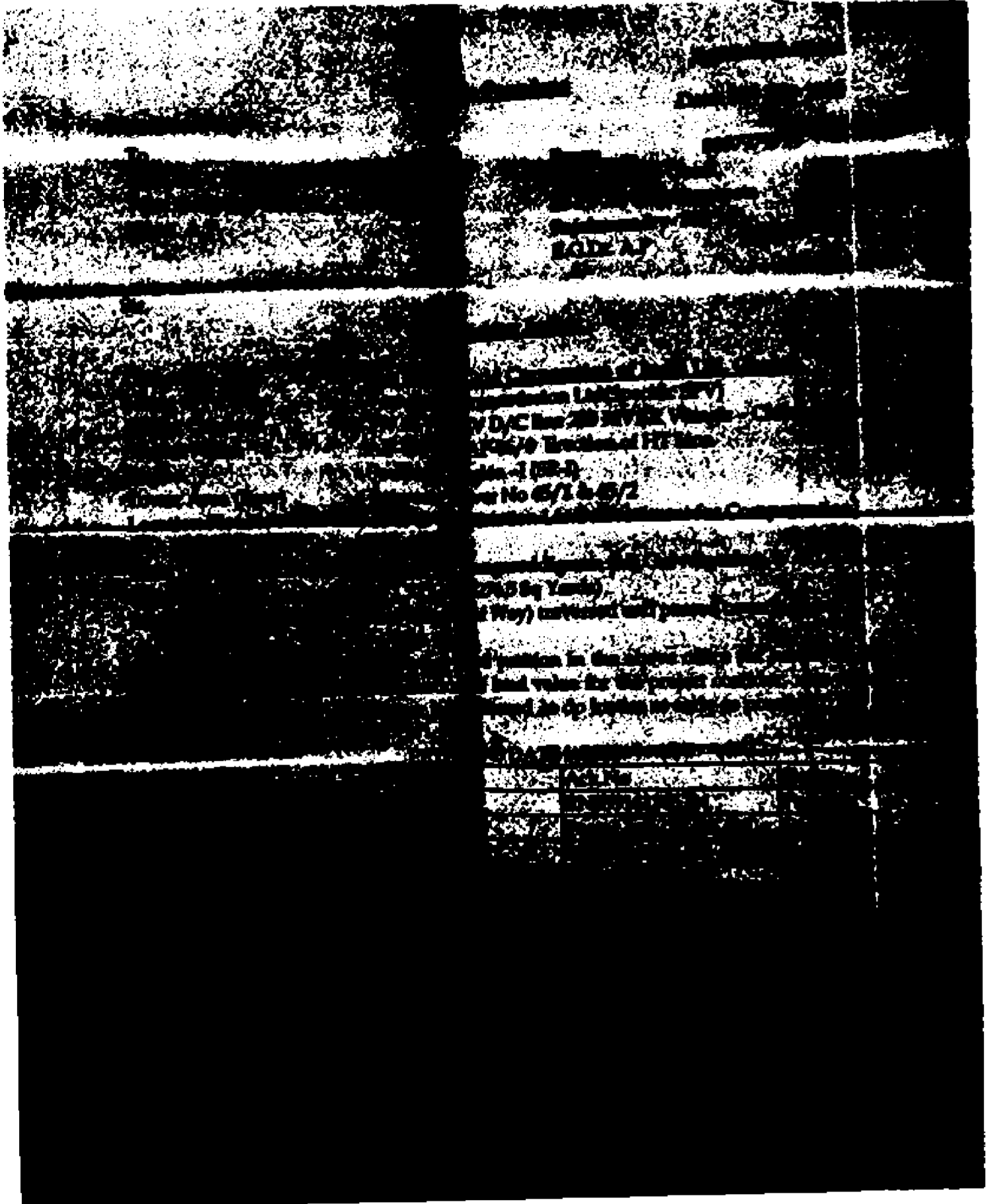
