- i) Requirement of employees are an internal matter of the CPSEs based on the work of the organisation and DPE does not have information with the requirement details as required by RTI applicant with regard to Question. Hence, the matter is being transferred to the CPIO of the CPSEs (with the RTI Application).
 - ii) It is informed; Department of Public Enterprises brings out an annual survey. The Public Enterprises Survey traditionally covers, beside certain statutory corporations, those Government companies wherein more than 50 % equity is held by the Central Government. The subsidiaries of these companies; if registered in India, wherein any CPSE has more than 50% equity are also categorized as CPSEs. The Survey, does not cover departmentally run public enterprises, banking institutions, and insurance companies
 - iii) Employee details are in the PE Survey Reports. The link of reports is provided. <https://dpe.gov.in/publication/pe-survey/pe-survey-report>. It is also informed that PE Survey Report of 2020-21 will be available in the website of DPE after placing in the Lok Sabha.
