Reply with respect to the question is as under:

1. It is informed; Department of Public Enterprises brings out an annual survey. The Public Enterprises Survey traditionally covers, beside certain statutory corporations, those Government companies wherein more than 50 % equity is held by the Central Government. The subsidiaries of these companies, if registered in India, wherein any CPSE has more than 50% equity are also categorized as CPSEs. The Survey, does not cover departmentally run public enterprises, banking institutions, and insurance companies. It is also informed that PE Survey Report of 2020-21 will be available in the website of DPE after placing in Lok Sabha.
2. Requirement of employees are an internal matter of the CPSEs based on the work of the organisation and DPE does not have information with the requirement details as required by RTI applicant with respect to Question No1. Hence, the matter is being transferred to the CPIO of the CPSEs (with the RTI application).
3. As per Question No 2, the details are annexed herewith.
4. As per Question No 3, refer to Statement No 27 for PE Survey 2019-20. <https://dpe.gov.in/public-enterprises-survey-2019-20>.
5. With respect to Question No 4, no information is available with DPE and it is informed the matter has already been transferred by DPE to Ministry of Statistics and Programme Implementation (MoSPI).
