I am here in the effected land owner of your corridor project served Notice to the above office on 17/01/19 in connection with the compensation for land damages, you replied as above, received by me on 2nd Feb 2019.

Firstly, congratulations that you have peacefully and successfully completed the corridor work in my land in the month of May-June 2018. I had never questioned you for neither the issue of Notice nor payment of compensation during the period of progress of work in my land. Since, I have faith and respect over the work of company against litigation whiles the work of nation importance in progress. Hence, I have sacrificed the land along with moral support and voluntarily sided to the corridor project.

Whereas, the company has ethically damaged my sentiment feelings as land owner by Sudden and surprisingly send me a Notice of compensation dated 17.01.19 using Indian Telegraph Act 2013. Even the signature on the Notice of Corridor No. 5766 is not mine, further I have not authorized anyone to do so. I am treating the Notice served by you as not proper and an insult caused to me after the event of moral damage.

If you really wish curtsy to inform me of the work of corridor in my land, you might have done to serve notice before enter and start work in my land seemed to be unfair. Therefore, Company is sole responsible for the cause of damages of mental agony along with land damages.

As a Government of India Enterprises Company, the authorities of PGCIL, should not have been misusing the Rights of the Indian Telegraph Act used u/s 164 dated 24.12. 2013. I have a right to fair compensation and a right to be informed of the work before going to start work in my land irrespective of any rules, guidelines or acts. Therefore the company has failed to maintain both the 'Indian Code' and corporate Governance in your business. I am in support of your business. Your company 'New Name Company' keep on stand.



Further I was deprived of the Right of Property and individual freedom permanently under charity.

The Fact:

1. I lost the moral of Right of Property and individual Freedom given by constitution.
2. The Cultivation relates to a traditional Lifestyle believing the Land as Goddess with love and affection of my "Family Sentiments" and "Financial Protection".
3. I lost both self respect and a future self INVESTMENT.
4. I am deprived permanently use of my own land ethically as per my wish and will for future development like Commercial/business/residence/industries etc..
5. Construction companies have full advantage as they permanently acquire life time rights to run their business for a nothing under mask of Charity. Whereas a disadvantage to me in the name of same Charity.
6. I cannot transfer the immovable property neither for a fair consideration nor gift to my legal heirs. No remedy available in my hands when, I am in emergency requirements or liquidation of funds for my family maintenance and development.
7. I am deprived to sale/mortgage my land to recover from loss, if failed in generating income by cultivation.
8. Banks / Creditors will not entertain, while sanctioning loans to the lands under Row.
9. The diminution land should be sold out for a discounted value depends on the extent and nature of damage occurred to my land. No one can rescue me and my family to

10. The Right was questioned equality under article 14 and 301A. Were pulled out from me.
11. The land sovereignty of the landowners by the depreciation of land cannot be improved as intends to abolish.
12. Identify that development is a pure free-standing development, while development should not impeded by someone else's development.
13. A huge reputational loss depressed me mentally and physically due to the diminution Land value.
14. It is very difficult to live as a whole farming income source is nothing but preventing me from self security.

A violation of a person's property rights is an expression of force against the person. The State should not use its coercive power to force a person to share his wealth with the less fortunate. True charity cannot be compelled.

Prayer:

I have shown my obedience in sacrificing valuable and loveable land to the nation. It is sheer injustice towards me, whose voice is being suppressed in this establishment of the corridor preventing me from grievance redressal mechanism by not informing me of the work done in my land. It is true to say, that I was simply stood outside of my land until completion of the project, even they have not paid a single rupee/penny till the date, even work has completed successfully a year back in 2018 is Ignorance of patriot.

Therefore, The Secretary MOP is kindly do Justice to me of the above. I was belong to economically weaker section of Back ward class society (B.C), unemployed used to survive my land for maintenance of my family, but was not sufficient to settle my two daughters in future, mere selling of land for a good price is one and only remedy in front of me keeping the facts in mind. Therefore an alternative remedy may be shown to my issue considering the points are noted of affected Right of Property and Individual Freedom under name of charity.

This has reference the communication Ref.No.190811POWERGRID00180 dated 13.01.2021 of Investor Services Cell of National Stock Exchange of India Limited, addressed to the Company Secretary regarding pending complaints against our Company.

The complaint pertains to 765 KV Vernagiri – Chilakaluripeta D/C line of PSITSL (Wholly owned Subsidiary of POWERGRID) who implemented the transmission project "Strengthening of Transmission System Beyond Vernagiri" under TBCB route.

Following reply is submitted to the above complaint filed by Sri Tallada Dillip Goud R/o Rajahmundry, Andhra Pradesh.

Gist of the complaint:

"The Complainant has complaint regarding govt. company damaged his land arbitrarily and not followed rule of law and misused his bank account to transfer an amount of Rs179520/- on April 18 2019 without any permission and non-acceptance subject to the notice dated Feb 15 2019 served to the company. Further, informed that the signature on the notice is not his. Further, he is requesting to kindly check and verify the rule of law, regulations and directives pertain to the project corridor, and analysis proper guidelines issued by REC, Ministry of power, Govt. of India to the best of knowledge to confirm by conduct enquiry to confirm for allegations made against the company are true or false. The company is sole responsible for the losses, detriment or inconvenience occurred to him in while using his land against law. Action may be taken accordingly as deemed fit in the interest on and behalf of the investors welfare. Or else irreparable loss occurred to him & to the company investors."

At the outset, this is to mention that the complainant has not mentioned in his complaint, which provision of law is violated by the Company.

1. It appears that the land, the complainant is referring to, is pertaining to RS No. 471, situated at Gurusigudem Village, Jangareddygudem Mandal in West Godavari District, Andhra Pradesh.
2. The 765kV Vernagiri-Chilakaluripeta Double Circuit Transmission Line is passing over the above land between Loc. No 45/1 to 45/2, as per the final route alignment. The total extent of the affected land beneath the above transmission line within the Right of way width is 1.883 acres as per the notice issued. No tower is placed in the above said land.
3. The said transmission line is part of an approved Scheme of "Strengthening of Transmission System Beyond Vernagiri" by Ministry of Power, Govt. of India, under Section 68 of Electricity Act, 2003 and executed through Tariff Based Competitive bidding (TBCB) process.
4. All the rules as stipulated by CEA, Ministry of Power, Govt. of India have been adhered to and a public notice was published in the leading newspapers about the route and commencement of the said transmission line.
5. Further, CEA, Ministry of power under section 164 of Electricity Act 2003, has conferred all the powers under section 164 of the Electricity Act, 2003 which the telegraph authority possess under the Indian Telegraph Act, 1885 with respect to the placing of telegraph lines and posts for the purpose of a telegraph established or maintained by the Government or to be so established or maintained for the works, vide Order dated 3rd August 2017.

6. Further in line with the guidelines issued by Ministry of Power Govt. of India dated 15th October 2015, Govt. of Andhra Pradesh issued GO RT No 83 dated 20.08.2017 for payment of compensation towards damages in regard to Right of Way for Transmission lines - 100% land value as compensation for the land within the tower base area and 10% of the land value as compensation towards diminution of land value in the width of corridor of 67meters.
7. Accordingly, in line with the above statute, a notice dated 17.01.2018 has been issued to the representative of Sri Tallada Dilip Gowd intimating the extent of his land affected beneath the above transmission line.
8. Subsequently compensation as per the rates determined by District Collector, West Godavari, amounting to Rs179520/- in full paid through net banking to his account towards land value diminution within Right of way width at the rates determined by District Collector, West Godavari District.
9. From the above, it is to submit that the said transmission line has been established using the said land as per the law. There was no illegality, infirmity and violation of any law in the action of the PSITSL in establishing the said Transmission Line.
10. Further, full compensation has been paid for the damage caused to the complainant as per Government Order RT No 83 Govt. of Andhra Pradesh and as assessed by the District Collector, West Godavari District. The compensation was duly accepted by the Complainant.
11. From the above submissions, it is clear that the allegations made in the complaint, are baseless and unfounded. Hence, it is requested that the complaint may be closed considering this reply.
