Refer your RTI no. DPENT/R/P/22/00030, under RTI Act, 2005 dated 02.06.2022 received in this Department on 02.06.2022, manually forwarded by CPIO of Department of Post with payment. In reply to particular Question 1 raised and connected to this Department it is stated that:

2. The Department of Public Enterprises (DPE) does not control any Central Public Sector Enterprises and does not have any PSUs under Department of Public Enterprises. However, it brings out an annual survey i.e., Public Enterprises Survey. The Public Enterprises Survey traditionally covers, beside certain statutory corporations, those Government companies wherein more than 50 % equity is held by the Central Government. The subsidiaries of these companies, if registered in India, wherein any CPSE has more than 50% equity are also categorized as CPSEs. The Survey, does not cover departmentally run public enterprises, banking institutions, and insurance companies.

3. The complete list of Central Public Sector Enterprises on the basis of category viz Schedule A,B,C etc as asked is available on website with link, <https://dpe.gov.in/about-us/policy-i-division/schedule-wise-list-cpses-october-2021>. Other. 
Please provide answers to the following queries.

4. When the PRP is due to an employee? Whether management can stop or delay PRP on any reason? If yes, list the reasons?
5. Show the list of companies controlled by department of Public Enterprises and not paid PRP for the FY 2018-19, 2019-20 and 2020-21 and reasons thereof for not paying PRP?
6. Whether DPE or Administering ministries are aware of non-payment of PRP to employees and any supervision is made for non-compliance of DPE order? What action taken by the administrative ministries and DPE in case of non-payment of PRP in time in PSUs under them?
7. What remedy is available to the employees if PRP is not paid by the management in time? Are they eligible for any compensation for delay in getting their dues in time?


