Subject: Information sought under RTI Act, 2005-regarding.

Refer your RTI no. DPENT/R/E/22/00232, under RTI Act, 2005 dated 04.06.2022 received online directly in this Department. Following is the reply to queries:

1. Revenue or income earned from government contracts is an internal matter of the CPSEs based on the contracts signed by the organisations. Also, the record of payments made by various government departments and ministries under various contracts including MOUs are maintained internally by concerned CPSEs. DPE does not have information with the details of contracts signed or entered into by various organisations as required by RTI applicant. Hence the matter is being transferred to CPIO of the CPSEs.
2. However, Department of Public Enterprises (DPE) brings out an annual survey i.e. Public Enterprises Survey. The Public Enterprises Survey traditionally covers, beside certain statutory corporations, those Government companies wherein more than 50 % equity is held by the Central Government. The subsidiaries of these companies, if registered in India, wherein any CPSE has more than 50% equity are also categorized as CPSEs. The Survey, does not cover departmentally run public enterprises, banking institutions, and insurance companies.
3. The link of Public Enterprise Survey Reports is being provided for reference purpose <https://dpe.gov.in/publication/pe-survey/pe-survey-report> . It is also informed that the latest Public Enterprises Survey Report 2020-21 will be available on the website of DPE after laying of the same in the Lok Sabha.
