**ORDER**

**Grounds of Appeal:**

Being dissatisfied by the information provided by the CPIO, POWERGRID, SR-II, Bangalore, vide his letter No.SR-II:RTI-F-1263(3)/21-22/III/3318 Dt: 08.03.2022 against the Request of the Appellant vide application dated 09.02.2022, the Appellant has filed this on the following grounds:-

The Appellant has stated that the CPIO Office had not furnished any information which has been requested by the applicant with respect to the application dated 08-03-2022 given and refusing without any reasonable cause.

The Appeal U/S 19 of RTI Act, 2005 Dt. 04.05.2022, received in this office on 09.05.2022. Upon receipt of the said Appeal, CPIO, POWERGRID, SR-II, Bangalore was called and the grievance made in the Appeal was explained to him. He furnished that the RTI request was replied vide letter No.SR-II:RTI-F-1263(3)/21-22/III/3318 Dt: 08.03.2022.

It is observed that the CPIO has replied the queries as sought in the application and provided within the time limit stipulated in the RTI Act,2005.

**Decision:**

I have examined the matter and dispose of the Appeal as under:

- a) The Appellant had filed an Application dated 09.02.2022 seeking information on compensation and pending court cases with regard to complete Raigarh-Pugalur HVDC Transmission System under the Right to Information Act, 2005
- b) The Reply provided to the Appellant vide letter dated 08.03.2022 are/is found to be satisfactory as the information sought by the applicant is vast and generous in nature and no specific query for the information sought.
- c) Therefore, the Appellant is hereby advised to raise query keeping in view of the limitation of the Public Authority.

With this order, the Appeal stands disposed of.
