ORDER

The Appellant **Shri Vivek Jhunjunwala, A-5, MAA Sharda Shopping Complex, Telipara, Bilaspur, Pin-495001** vide his Online RTI Application Registration No.PGCIL/R/E/22/00233 Dt. 07.07.2022 had requested for furnishing information under the provisions of Right to Information Act, 2005. CPIO, NR-I has provided information as per the provisions of RTI Act-2005 through RTIMIS Portal on 05.08.2022 and denied for providing of information under section 11(1) and 8(1) (d).

Now, first Online RTI Appeal vide Registration No.PGCIL/A/E/22/00037 Dt.09.08.2022 u/s 19(1) of the RTI Act, 2005 has been filed by Appellant Shri Vivek Jhunjunwala. In his appeal, the appellant mentioned that the *desired information is normal and have to be provided by non-providing the same and taking hide of different type of section to kept the information secret is not viable. The appellant further mentioned that if this was the thing no party will allow the company to disclose the information and, in that case, there will be no use of RTI and information desired by him should be provided.*

Ongoing through the contents of Online RTI Application dt.07.07.2022, Appeal Dt.09.08.2022 and subsequently the submission of CPIO, POWERGRID, NR-I has been heard. Further the contents of Appeal Dt.09.08.2022 has again been forwarded to CPIO, POWERGRID, NR-I and directed to look into the matter again and take the opinion of the concerned Department as per the provisions of RTI Act, 2005. Accordingly, the concerned Department has further informed that the information sought is pertains to Third Party i.e., M/s Linxon India Pvt. Ltd. and described sensitive by them. M/s Linxon has also not agreed for sharing the desired information to any third party. Therefore, the information cannot be provided and exempted under section 8(1) (d) and 11(1) of RTI Act-2005.

Now, ongoing through the above discussion, it is concluded that the information desired is exempted under the provisions mentioned above and the information sought cannot be provided. Hence, the appeal is disposed-off.
