

Information sought:	Reply:
<p>This is Sunil Kumar Suman, I was employee in Power Grid Corporation of India Limited. Our Posting was Bhubaneswar PGCIL office. Our present Employee Id was 90086475 and previous Employee id was 90086220. My first Tenure had completed in 28 June 2018 and again Rejoined dated on 12.07.2018. After new joining, I had merged the previous EPF account. Our 2nd Service tenure has completed dated on 31.12.2021 and our Total service period was Eight years (8 years).</p> <p>After Three months, I have applied for EPF withdrawal form through online dated on 31.03.2022 and total amount was Rs.983570.86. But I have received a sum of Rs.899127 only dated on 24.05.2022. But I have applied for withdrawal the EPF amount Rs.983570.86 and rest amount was deducted from your side. As per GOI, there will be no TDS deduction after Five years. After deducting I have talked to Shri Sushil Kumar, He told me, I have no knowledge, you was working 8 years. So, I have deducted the TDS amount. How much deducted TDS amount, please provide to me deducted documents but he denied the documents.</p> <p>So, I want to know in which basis you deducted the TDS amount and how much amount was deducted by you. Whereas GOI Rules says, EPF is withdrawn before 5 years:- If you withdraw from EPF before completing 5 years of continuous service, TDS will be deducted. In calculating 5 years of service, your tenure with the previous employer is also included. If you transfer your EPF balance from the old employer to a new employer and your total employment is 5 years or more, no TDS is deducted. Do remember that you must calculate the exact 5 years, there is no grace if you are short by a few days.</p>	<p>TDS has been deducted and deposited on PF withdrawal in accordance with Income Tax Act. As per the Employee's PF Form-C application, Date of Joining is 12/07/2018, which is less than 5 years, accordingly, TDS of Rs. 99,904/- has been deducted @10% of Settlement Amount. TDS certificate shall be issued to employee in due course.</p>
