#### **ORDER**

### **Grounds of Appeal**

The Appellate Authority has received an online RTI Appeal bearing number PGCIL/A/E/22/00046 dated 27/09/2022 from Shri Rahil, (appellant). Earlier, the appellant herein had filed the RTI application bearing number PGCIL/R/E/22/00242, dated 15/07/2022. The appellant has preferred the instant appeal on the ground that requisite information against SI. no. 7 of RTI application dated 15/07/2022 has not been provided.

#### Order:

I have seen the above mentioned RTI application filed by the appellant. I have also perused the reply dated 10/08/2022 sent by the CPIO wherein against SI. no. 7 of RTI application the CPIO had mentioned that the information sought cannot be provided as the same is unavailable as on date. The information as was available has already been provided vide the reply dated 10/08/2022. The appellant has preferred the instant appeal on the ground as he was not given the question paper as well as the answer key.

It can be noticed that no roll number has been provided by the appellant herein. Moreover, except for the name of the village no other detail has been provided in the name of address. Though the appellant has mentioned that he had appeared for the exam but instead of providing his details (roll number, complete

communication address) he has provided admit card in that name of sh. Piyush Gupta. In my considered opinion the appellant has not only failed to provide his requisite details but also failed to mention any reason why he did not use the opportunity to download the question paper and model answer key when the same was available during 25.06.22 to 28.06.22. The said opportunity was available for all those who took the test.

Be that as it may, the question paper along with the answer key of the appellant can be provided to him subject to verification of his credentials (admit card, roll number and complete communication address etc.). The information shall be provided, if available, within fourteen days from the date of receiving of the requisite details, if such details are received from the appellant within seven days from the date of this order. As mentioned hereinabove, the same will be subject to exceptions provided under the Act.

The appeal is accordingly disposed of.
