As per Clause 0.5.4 of the Memorandum of Agreement signed in the PNBC in the year 1995, POWERGRID provide employment to one of the dependents of each workman who is permanently disabled or dies as a result of accident while on duty. The above provision was also extended to employees in Supervisor and Executive cadre upon approval of Competent Authority.
3.	Please also inform about the future benefits to the deceased dependent from the department.	The query pertains to a future event and accordingly answer to this query does not qualify as "information" as per clause 2(f) of the RTI Act 2005.
