<b>Text of RTI First Appeal :</b>	<p>The learned CPIO deprived me from my right of access to information as no information is provided, except point 1, 8 &amp; 9 (however, these are also not complete information). On perusal, this is also self evident that certified copies of relevant documents, related to even single information / basis on which CPIO gave rulings, has not been provided to me. It is pertinent to mention here that similar RTI Online Applications was registered with certain Ministries, PSUs, PSBs, RBI, DFS, NITI AAYOG, CAT, UT State Legislative Authority Chandigarh etc &amp; point wise specific information along with certified copies of relevant documents have been made available by each of these Institutions. Some copies are though enclosed however not complete &amp; to the point, please revisit &amp; review. In reply of point 3 the contents mentioned in page 14 of the so called rule 28 of the Oriental insurance Company (Conduct. Discipline &amp; Appeal) Rule 2014, mentioned on page 14 of such rules has nothing to do with the mode &amp; process of serving of Charge Sheet upon an Officials instead this is related to delivering orders of disciplinary authority along with the Inquiry Report which comes last in the process of any departmental inquiry whereas serving of charge sheet is the very first step of the same. Sir, In light of above, I once again humbly request to provide me specific point wise information along with certified copies of relevant</p>		

documents, especially in due consideration of commitment of criminal offences in PSU / PSB & hence exposing them involve larger public interest.
