It is informed that the Department of Public Enterprises is the nodal department for all the Central Public Sector Enterprises (CPSEs) and formulates policy pertaining to CPSEs. It lays down, in particular, policy guidelines on performance improvement and evaluation, autonomy and financial delegation and personnel management in CPSEs. It furthermore collects and maintains information in the form of a Public Enterprises Survey on several areas in respect of CPSEs. The Public Enterprises Survey traditionally covers, beside certain statutory corporations, those Government companies wherein more than 50 % equity is held by the Central Government. The subsidiaries of these companies, if registered in India, wherein any CPSE has more than 50% equity are also categorized as CPSEs. The Survey, does not cover departmentally run public enterprises, banking institutions, and insurance companies.

As all queries of the applicant are either related to EWS reservation or status of EWS quota in PSUs etc. Regarding the details information and as also considering it internal administrative matter of CPSEs, it is being transferred to the CPIO of the CPSEs (RTI Application enclosed) to provide information directly to the applicant.
