- 3. What are the period(s) of service required for long service under above rules/scheme/order in the Maharatna CPSEs?
- 4. Please provide of copy of above circular/order/policy/scheme etc. PIO is requested to provide above information as per Section 6 (3) of the RTI Act.
- 2. The CPIO vide his reply dt 18<sup>th</sup> August, 2022 provided a copy of the Maharatna guidelines to the applicant issued by DPE on 4<sup>th</sup> February, 2020. Aggrieved by the reply the applicant filed an Appeal vide RTI appeal no. DPENT/A/E/22/00026 dt. 20<sup>th</sup> August, 2022.
- 3. The undersigned has gone through the Appeal filed by the applicant on the reply furnished to him by the CPIO. The undersigned has observed that the applicant wanted to know whether any scheme is there to recognize the long service rendered by any employee of Maharatna. The applicant is informed that Maharatna CPSEs have been granted autonomy in the matters relating to HR related issue as detailed in the guidelines at 04.02.2010 which was shared with the applicant by the CPIO. Apart from the no specific guidelines on recognition of long service in Maharatna CPSE have been issued by DPE.
- 4. The applicant is further informed that under the RTI only the information available with the CPIO can be provided & further replies to queries are beyond the scope of the RTI. However, since Maharatna CPSEs are separate public authorities, CPIO is directed to forward a copy of the RTI application to the CPIOs of all, Maharatna CPSEs within five working days to supply the requisite information directly to the applicant.
