**ORDER**


1. The appelland has made an appeal dated. 29.12.2022 against information provided by the CPIO vide letter dated. 01.11.2022 to his RTI application dated. 10.10.2022.
2. On perusal, it is found that the said RTI application ref. no. PGCIL/NER/2022-23/M-21 dated. 10.10.2022 received at CPIO, NERTS's office on 26.10.2022, had asked for information pertaining to 132kV S/C Seppa-Rillo, Rillo-Seijosa, Rillo-Sagalee TL & 132kV power station shifting from Rillo to Pakke-Kessang under Comprehensive T&D scheme, Arunachal Pradesh. The application was partially responded by CPIO, NERTS on 01.11.2022 and the remaining query has been forwarded to SPIO, Department of Power, Itanagar on 15.10.2022.
