As per the above mentioned notification published for the (Refer Page No 8) post code **199** with post name as **Assistant Manager (Dot net/ Java/ Mobile/UI5 appln. developer) – 04 Nos** the **Essential Post Qualification Experience** is mentioned as :

**Before Relaxation:**

Candidates Should have **Three years** post qualification experience in Executive/Gazetted officer cadre of which at least **two years** in following pay scale or equivalent level\*\*:

**IDA** : Rs. 50,000 – 1,60,000 or

**Govt** : Candidates should be holding gazetted post (at least Gr-B)

\*\*Private sector: Minimum Monthly gross emoluments of Rs. 76500/-

Coming to **RELAXATIONS AND CONCESSIONS** (Refer Page No 13) Point no 3. Mentioned as **Relaxation in Post Qualification Executive/ Gazetted Cadre Experience:**

In case of reserved posts, the post qualification experience shall be relaxed for candidates belonging to SC/ST/PwD categories by:

| Post ID        | Relaxation in post qualification experience |
|----------------|---|
| 199, 201 & 202 | Maximum of 01 year for SC/ST                |
| 195            | Maximum of 02 years for SC/ST & PwD-HI      |

As per the above points considering relaxation for SC Candidate, I am presuming **Essential Post Qualification Experience** as per the bellow

**After Relaxation:**

Candidates Should have **Two years** post qualification experience in Executive/Gazetted officer cadre of which at least **one years** in following pay scale or equivalent level\*\*:

**IDA** : Rs. 50,000 – 1,60,000 or

**Govt** : Candidates should be holding gazetted post (at least Gr-B)

\*\*Private sector: Minimum Monthly gross emoluments of Rs. 76500/-

Under **RELAXATIONS AND CONCESSIONS** (Refer Page 13) of notification Point No 1 mentioned as Reservation/Relaxation/ Concession to candidates belonging to different categories shall be as per **Government of India directives**.

Why there is no Relaxation/Concession given to the SC/ST/PWD Candidates in the essential post qualification experience in the number of years wise(that mentioned atleast **TWO years**) OR pay scale wise/ equivalent Level wise\*\* OR Both ?

**IDA** : Rs. 50,000 – 1,60,000 or

**Govt** : Candidates should be holding gazetted post (at least Gr-B)

\*\*Private sector: Minimum Monthly gross emoluments of Rs. 76500/-

Why there is no point mentioned anywhere in the notification that there is no relaxation given to SC/ST/PWD candidates in the essential work experience that they should work at least two years in the given pay scale.
