1.	Please answer the following questions: 1. In the Northern Region -1 locations Rhq Faridabad, Ajmer, Kota, jaipur how many executives are there who are due for promotion from E6 to E7 in year 2024.	The query pertains to individual's speculation regarding a future event and accordingly answer to query does not qualify as "information" as per Section 2 (f) of the RTI Act, 2005.
2.	Out of the executives in Northern Region -1 locations Rhq Faridabad, Ajmer, Kota, Jaipur who are due for promotion from E6 to E7 in year 2024, how many executives are there who have not been posted in difficult location yet. According to transfer policy (clause 5.8) executive must be transferred to difficult location before being promoted for E7 grade. What is the reason that these executives due for promotion from E6to E7 have not been posted at difficult location yet. Is there some malpractice being carried out in company which indicates employee not being transferred to difficult location in spite of being due for promotion from E6 to E7. Why company is not doing job of rotating the executives according to transfer policy (clause 5.8) who are due for promotion from E6 to E7.	Already replied to in Query No. 1 above.
