ORDER

Grounds of Appeal

The Appellate Authority has received an online RTI Appeal bearing number PGCIL/A/E/23/00005 dated 23/01/2023 from Shri Sathish Kumar (appellant). Earlier, the appellant herein had filed an offline RTI application bearing number PGCIL/R/E/22/00434, dated 26/12/2022, which was returned to applicant by CPIO mentioning that the information sought does not pertain to POWERGRID. The instant appeal has been preferred on the ground that the CPIO has refused access to information requested.

Order:

I have seen the above referred RTI application wherein the applicant had requested to provide certain information pertaining to one Shri K Venkata Kanaka Durga Vara Prasad, working in APGENCO (Andhra Pradesh Power Generation Corporation Limited). The RTI was returned to applicant by CPIO mentioning that the information sought does not pertain to POWERGRID. The appellant herein has preferred an appeal, despite the remark from CPIO that the information sought does not pertain to POWERGRID. I have noticed that the education status of the appellant is illiterate. In my considered opinion, ends of justice would be met if the application is forwarded to the CPIO, APGENCO. CPIO, POWERGRID is hereby directed to forward the application to APGENCO within five days of this order.

The appeal is accordingly disposed of.
