ORDER

Grounds of Appeal

The Appellate Authority has received an online RTI Appeal bearing number **PGCIL/A/E/23/00008 dated 17/02/2023** from Sh. Deep Kumar Mondal (appellant). Earlier, the appellant herein had filed an RTI application bearing reference number PGCIL/R/E/23/00054 dated 30/01/2023, with the CPIO Corporate Centre. The instant appeal has been preferred on the ground that the CPIO has not provided the details.

Order:

I have seen the aforesaid RTI application wherein the appellant herein had sought information regarding eligibility of a candidate for technical post having high myopia corrected by LASIK/ ICL surgery. I have also perused the reply dated 17/02/2023 and other relevant documents. It can be seen that CPIO had provided the link to access the medical fitness standard on POWERGRID website containing the information sought in the RTI application. In sum and substance, the appellant is seeking information related to his candidature for technical post having high myopia corrected by LASIK/ ICL surgery. Basically, the appellant is seeking information in black and white related to aforementioned ailment. Ends of justice would be met if the information with clarification related to suitability of a candidate with high myopia corrected by Lasik/ ICL surgery is provided to the appellant. CPIO is hereby directed to provide the information within fourteen day of this order.

The appeal is accordingly disposed of.
