

First appeal under section 19 (1) of the R. T. I. Act, 2005, against  
respondent for not providing the information sought through application  
dated 10/02/2023, moved under section 6 (1) of the R. T. I. Act, 2005.

Hon'ble Madam,

Appellant most respectfully and humbly submits as under:-

1. That appellant is a citizen of India and has legal right to get information from any public authority under the Right to Information Act, 2005.
2. That office of the respondent falls within the purview of public authority and is legally bound to provide information sought under The R. T. I. Act, 2005.

3. That an application dated 10/02/2023, seeking information under section 6 (1) of the R. T. I. Act, 2005, was moved to the respondent CPIO through speed post vide postal receipt number EH623339748IN dated 10/02/2023, issued by post office Farrukh Nagar Distt. Gurugram, Haryana.
4. That required fee of rupees ten in the form of **Indian Postal Order** bearing number 57F 669426, issued by post office Farrukh Nagar, Distt. Gurugram, Haryana, on dated 06/12/2022, was attached with the RTI application dated 10/02/2023.
5. That subject matter of information is that applicant Suresh Kumar S/o Late Sh. Ram Kumar is a permanent resident of village Jhanjhrola-Khera, P.O. Sultanpur, Block & Tehsil Farrukh Nagar, Distt. Gurugram, Haryana. He has worked as SECURITY GUARD in your office from 04/04/2021 to 03/02/2023. He has moved a written complaint dated 16/01/2023, jointly addressed to the Chairman & Managing Director, Director (Personnel) and Chief Vigilance Officer (POWERGRID), Power Grid Corporation of India Ltd, Corporate Office: Saudamini, Plot No. 2, Near IFFCO-CHOWK, Sector-29, Gurugram, through speed post vide postal receipts dated 16/01/2023. As per Indian Post Tracking Report same has been delivered on dated 17/01/2023 to the Director (Personnel) and Chief Vigilance Officer (POWERGRID) and on dated 19/01/2023 to the Chairman & M.D. After getting no response REMINDER dated 04/02/2023 has been sent through speed post dated 04/02/2023 and copy of the same was sent through official E-Mail IDs, but till today nothing has come to fore so far. Matter is concerned with the complaint against ASO SANJEEV SHARMA and EX-ASO PURSHOTAM DASS SHARMA regarding illegal works.

As per Contract Labour (Regulation and Abolition) Act, 1970 and Contract Labour (Regulation and Abolition) Rules. POWERGRID

Surely

is a "**PRINCIPAL EMPLOYER**", of the labourers working under contractor (s) under its jurisdiction.

Section 21 of the Contract Labour (Regulation and Abolition) Act, 1970 fixes the responsibility of the Principal Employer for Payment of Wages. CHAPTER VI (WAGES), Rule 72 and Rule 73, of The Contract Labour (Regulation and Abolition) Central Rules, 1971, which is applicable in the State of Haryana also stipulates the duty of the Principal Employer regarding distribution of wages by the contractor.

**Rule 74 in CHAPTER VII** stipulates that Every Principal employer shall maintain in respect of each registered establishment a register of contractors in Form XII.

**Rule 78. Muster Roll, Wages Registers, Deduction Register and Overtime Register.—**

[(1) (a) Every contractor shall in respect of each work on which he engages contract labour.— (i) maintain a Muster Roll and a Register of Wages in Form XVI and Form XVII respectively: Provided that a combined Register of Wage-cum-Muster Roll in Form XVIII shall be maintained by the contractor where the wage period is a Fortnight or less: (ii) maintain a Register of Deduction for damage or loss, Register of Fines and Register of Advances in Form XX, Form XXI and Form XXII respectively; (iii) maintain a **Register of Overtime** in Form XXIII recording therein the number of hours of, and wages paid for, overtime work, if any; (b) (c) (d) Every contractor shall, where the wage period is one week or more, issue wage slips in Form XIX, to the workmen at least a day prior to the disbursement of wages; Every contractor shall obtain the signature or thumb

impression of the worker concerned against the entries relating to him on the Register of Wages or Muster Roll-cum-Wages Register, as the case may be, and the entries shall be authenticated by the initials of the contractor or his authorized representative and shall also be duly certified by the authorized representative of the principal employer in the manner provided in rule 73.

Applicant has moved a complaint dated 16/01/2023 and after that its reminder dated 04/02/2023 to the senior most authorities of the POWERGRID. Matter is concerned with the aforesaid AGENCY engaged by the POWERGRID (Principal Employer). Principal Employer is empowered under the aforesaid provisions. Hence this RTI. Information is concerned with the same subject. **Requisite information be provided point-wise, duly attested and in annotated form.**

Sought information is as under:-

- a) Provide complete details of steps taken by the department on the complaint dated 16/01/2023 and its reminder dated 04/02/2023.
- b) Provide certified copy complete enquiry report, if any, conducted by the department on the aforesaid complaint dated 16/01/2023 and its reminder dated 04/02/2023, providing name of the enquiry officer, his contact number and designation.
- c) Provide complete data of attendance of all guards, marked, by the "PARVEEN KUMAR GOYAL SECURITY AGENCY (PKG Security Agency)", through "BIOMETRIC ATTENDENCE SYSTEM (BAS)", ATTENDANCE REGISTER's certified copy,

WAGE REGISTER's certified copy, pertaining to entire month of MAY 2021 and OCTOBER 2022 regarding all guards.

- d) Provide complete details of each and every security guard's DEDUCTED AMOUNT, which have been deducted from the salary of month 2022, of every security guard to recover SO CALLED EXCESS AMOUNT on the name of excess amount, earlier paid to them, pertaining to their last 10 months salary, certified copy of official order issued by the competent authority of POWERGRID regarding alleged deduction for recovery.
- e) Provide certified copy of OVERTIME REGISTER pertaining to the MONTH OCTOBER, 2022, in respect of all guards employed by the aforesaid agency.
6. That as per Indian Post Tracking Report, item booked at Farrukh Nagar SO, through postal receipt number EH62339748IN dated 10/02/2023, has been shown delivered on dated 11/02/2023.
7. That **THIRTY FOUR DAYS** have passed when the said RTI application dated 10/02/2023 has been delivered to the office of the respondent on dated 11/02/2023 but no information has been provided by the respondent so far.
8. That as per Sub Section 2 of Section 7 of the RTI Act, 2005; If the Central Public Information Officer or State Public Information Officer, as the case may be, fails to give decision on the request for information within the period specified under sub-section (1), the Central Public Information Officer or State Public Information Officer, as the case may be, shall be deemed to have refused the request.
