

1.	Provide complete details of steps taken by the department on the complaint dated 16/01/2023 and its reminder dated 04/02/2023	On examination and reference of the issue raised to the concerned Proprietor including their representative, it was ascertained that there was no theft as the material, i.e., pickle and cloth material was given by the respective vendors willingly.
2.	Provide certified copy complete enquiry report, if any, conducted by the department on the aforesaid complaint dated 16/01/2023 and its reminder dated 04/02/2023, providing name of the enquiry officer, his contact number and designation.	As regard deduction of amount from their salary, the matter was examined and it was found that recovery was effected by the Security Agency on account of payment of bonus, since their minimum wages exceeded the threshold limit of Rs. 21,000/-.
3.	Provide complete data of attendance of all guards marked, by the "M/s. Parveen Kumar Goyal Security Agency", through "BIOMETRIC ATTENDANCE SYSTEM (BAS)", Attendance Register's certified copy, wage register's certified copy, pertaining to entire month of MAY 2021 and OCTOBER 2022 regarding all guards.	The information sought relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual, therefore, the same is exempted under Section 8(1)(j) of the RTI Act, 2005.
4.	Provide complete details of each and every security guards DEDUCTED AMOUNT, which have been deducted from the salary of month 2022, of every security guard to recover SO CALLED EXCESS AMOUNT on the name of excess amount, earlier paid to them, pertaining to their last 10 months salary, certified copy of official order issued by the competent authority of POWERGRID regarding alleged deduction for recovery.	The information sought is exempted to be disclosed, as per Section 8(1)(j) of the RTI Act, 2005. However, recovery was effected by the Security Agency on account of payment of bonus, since their minimum wages exceeded the threshold limit of Rs.21,000/-.
5.	Provide certified copy of OVERTIME REGISTER pertaining to the MONTH OCTOBER 2022 in respect of all guards employed by the aforesaid agency.	No overtime was paid.
