Information sought:	POWERGRID's Reply:
<p>Q.2 Please furnish the photocopy (s) of document (s) from your office record in respect of compensation manual/ guidelines pertaining to payment of compensation amount as per the Electricity Act, 2003 to any house owner/ factory owner for installation of 220 kV D/c EHV Transmission Line (or higher kV Line) over his/ her/ their said premise which is located in an area which is jurisdiction of your office [Period of information: 01.01.2015 to 31.01.2023]</p>	<p>Following guidelines are followed for Compensation for transmission lines: Transmission lines in the Country are constructed under the ambit of Electricity Act, 2003. POWERGRID has been vested with the powers of Telegraph Authority vide MoP's Gazette Notification dated 24.12.03 under sec 164 of the Electricity Act. The provisions stipulated in section 67-68 of the Electricity Act, 2003 read with section 10 & 16 of the Indian Telegraph Act, 1885 govern the compensation. As per the provision under section 10 (d) of "Indian Telegraph Act, 1885", all damages assessed and ratified by Revenue authorities are being paid to land owners/ farmers. Due compensation for all damages such as tree, crop, wells, borewells, houses and other structure, if affected, is paid to all affected persons. With regard to crop and tree compensation, the compensation is determined as per extent of actual damages (jointly measured by revenue officials, land owners & POWERGRID) and depending on the type of crop/ tree etc. damaged, the compensation is assessed by concerned revenue officials and same is paid by POWERGRID. For assessing the value of timber yielding trees, help of forest officials is taken and for fruit bearing trees, help of Horticulture department is taken. With regard to compensation for borewell, houses etc., compensation for structure is payable in case the structure needs to be removed to maintain electrical clearance as per Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulation, 2010 notified by Central Electricity Authority vide Gazette dated 20.09.2010. For assessing the eligibility of compensation, the regulation of CEA may be referred. The regulations are available on following link: https://cea.nic.in/regulations-category/measures-relating-to-safety-and-electricsupply/?lang=en Assessment of the value of such structures is done by local PWD officials/ revenue authorities etc. As regard payment of compensation for land occupied by tower and corridor, it is to inform that Ministry of Power issued guidelines on 15.10.15 for payment of compensation towards damages in regard to Right of Way for transmission lines which provides payment of 85% of land value for tower base area and 15% of land value towards diminution of land value in the width of Right of Way (RoW) corridor. As per point No. 4 of the said guidelines, the guidelines are to be adopted by the respective States/ UTs and appropriate direction/ order have to be issued for its implementation.
