1.	WHAT IS THE CRITERIA TO DECIDE THE COMPENSATION AREA WHERE TRANSMISSION LINE PASSED.	The crop compensation during the construction of transmission line is evaluated based on the area of standing crops actually damaged during construction activities.
2	IF LINE PASSES THROUGH AGRICULTURAL LAND, THE AREA BELOW LINE AND NEAR BY AREA HAVE AIR CURRENT, WHERE CULTIVATION IS NOT POSSIBLE. WHAT IS THE PROCESS FOR COMPENSATION FOR THAT LAND.	The provision of crop compensation is defined for the standing crops damaged during construction work. Also, the line design and construction have been executed in line with safety parameters defined in Electricity Act, 2003 & Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010 maintaining adequate electrical clearance from ground and nearby structures. There is no hindrance to crop cultivation nearby & under transmission lines as evident in already existing transmission lines across nation where cultivation are being done unhindered.
