
Subject: Information sought under RTI Act, 2005 of Budumuru Nageshwar Rao reg; (Ref- DPENT/R/T/23/00048 **dated:** 07/03/2023)

Refer to RTI Reg.no. DPENT/R/T/23/00048, under RTI Act, 2005 received in this Office on 07/03/2023, transferred from Directorate General of Employment on 07/03/2023 With Reference Number: DGEAT/R/E/23/00072.

It is informed that the Department of Public Enterprises is the nodal department for all Central Public Sector Enterprises (CPSEs) and formulates policy pertaining to CPSEs. It lays down, in particular, policy guidelines on performance improvement and evaluation, autonomy and financial delegation and personnel management in CPSEs. It furthermore collects and maintains information in the form of a Public Enterprises Survey on several areas in respect of CPSEs. The Public Enterprises Survey traditionally covers, beside certain statutory corporations, those Government companies wherein more than 50% equity is held by the Central Government. The subsidiaries of these companies, if registered in India, wherein any CPSE has more than 50% equity are also categorized as CPSEs. The survey, does not cover departmentally run public enterprises, banking institutions, and insurance companies.

The information sought by the applicant specifically regarding availability of vacancies in CPSEs (as any information relating to PSBs and Financial Institutions is not available in records of DPE) and other detail procedures of selection including criteria for final placement for entry level or fresher CA/CMA in these CPSEs, are altogether internal administrative matters of individual CPSEs and may vary according to requirements of concerned CPSEs. Hence, all raised Queries 1-5 which pertain to internal administrative matter of CPSEs is being transferred to all CPIO of the CPSEs with supposition to reply directly to the applicant.
