| <p>Dear Sir, I am working with the NHAI Project of Bharathmala Road project which is time bound and i am raising the query regarding the payment of interruption charges for shifting of utilities like LT/HT which are 11 and 33KV and EHT (132,220,400 KV Lines). For the shifting of these lines in NHAI Bharathmala Project is there any requirement to pay the interruption charges, or as per any circular interruption charges will be waived off? Kindly please respond quickly</p> | <p>As per "Standard Operating Procedure (SOP) for shifting of Transmission Line by various infrastructure Developers" issued by the Ministry of Power Vide Letter Ref: F. NO. 34-3/18/2022-TRANS (MoP) dated 03.03.2023 (link of document given below), it is mentioned in point No. 15 and point 16 that:</p> <p>Point 15: As per Ministry of Power's OM No. 34-311812022-Trans dated 03.08.2022, the RPC Secretariat shall provide deemed availability certificate for the shutdown period availed by transmission licensee (both RTM and TCB) for shifting of their ISTS lines for all National Infrastructure Projects of NHAI, Railways, BRO etc., provided transmission customers are not affected by the shutdown of the line. All such applications for deemed availability shall be considered irrespective of date of application. However, deemed availability for past shifting of lines, where the diversion work has already been completed, shall not be considered.</p> <p>Point 16: For the cases where deemed availability certificate for the shutdown period is not issued to transmission Licensee for the shutdown period or part thereof, then in such cases, charges towards loss of availability due to such shutdowns shall be borne by Infrastructure Developer.</p> <p>Link for SoP Shifting of Transmission Line:</p> <p>Procedure_for_Shifting_of_Transmission_Lines_involving_in_work_by_other_Infrastructure_Developers.pdf (https://cea.nic.in)</p> |
