Region was informed verbally to inform you so as to get it corrected, but the duly corrected documents could not be received. Finally, the case was sent to EPFO on 25/10/2021 along with 'Joint Declaration Form' with the same documents as provided by you for correction in your Father's Name in EPFO's records.</p> <p>In this regard, an Official Note dated 06.06.2023 was received about the visit of Enforcement Officer to our Establishment, but no visit was made. However, a call was received on 09/06/2023 from Ms Sudha Kalra, E.O., EPFO, Dwarka, New Delhi office on the subject and she apprised us about the discrepancies and informed that it comes under Major Correction.
