Q.1.	<p>Dear Sir/Mam,</p> <p>Information Sought If a candidate who joins PGCIL as an Engineer Trainee through GATE 2023(Advt. No. CC /06/2022 dtd. 09.09.2022) and wants to switch to job in another PSU without successfully completing the prescribed training period or serving PGCIL for at least three years thereafter,</p> <p>Will the Service Agreement Bond be transferred from PGCIL to another PSU?</p>	<p>POWERGRID Rule:</p> <p>Transfer of Service Agreement Bond is allowed in case of those Trainees/employees who had applied for other Government jobs in Central/State, PSUs (Central/State), Quasi-Government Organisation prior to joining POWERGRID and desire to resign from POWERGRID to join such organisations subject to the condition that the new organisation takes from him a fresh bond binding him to serve them for the balance of the original bond period; in case he/she fails to serve the new department/organisation etc. or leaves it before completion of the original bond period for a job where exemption from bond obligation is not available, the proportionate bond money should be realised from the individual and refunded to the first organisation with whom he originally executed the bond.</p>
Q.2.	<p>Will the candidate have to pay the Service Agreement Bond amount to PGCIL?</p>	<p>As per Service Agreement Bond, if a candidate leaves the Company during training period, he/she will compensate the Company for salary, joining expense, TA/DA, medical expenses etc. paid during the training period and training expenses incurred by the Company on account of and in connection with his/her training. However, the total amount recoverable under this clause shall not exceed the bond amount.</p>
